Organizer License Agreement

This agreement is between the Train & Multiply Joint Venture and:

Train & Multiply®, T&M® materials will be used in my personal ministry adhering to the intent and details of this Organizer License Agreement and the guidelines in Appendix A.

The Organizer agrees to each and all of the following terms and conditions:

1. **An Organizer refers to an individual** who starts the Train & Multiply process in a new context. They are licensed by the Train & Multiply Joint Venture to use Train & Multiply materials to make disciples, plant churches and train pastoral workers. This person may use the T&M® materials for their intended purpose and distribute them to the pastoral workers or trainees, within the boundaries of their own ministry. Pastoral workers trained by an Organizer are by definition users who may reproduce T&M® materials for their intended purpose in accordance with the limitations of the organizer described in this License Agreement.
2. **This Organizer License Agreement is not transferable to others.** It may remain yours as you relocate to a different ministry or location.
3. **Project WorldReach and One Mission Society are the sole copyright owners,** authors and proprietors of all components, versions and derivatives of all Train & Multiply® materials in any form, format or method of production including art.
4. **Organizers and Users cannot sell, lend, give or provide in any way, or in any format, copies of the Train & Multiply® materials** to any person, group or organization outside the Organizer Boundaries as defined in Appendix A without the prior written consent of the Train & Multiply Joint Venture. The Organizer will refer all requests for the Train & Multiply® materials coming from outside the terms of this License Agreement to an Authorized Trainer.
5. **The Organizer may reproduce only Train & Multiply® materials which are current Authorized Versions** from originals in licensed languages, as provided by the Train & Multiply Joint Venture. Authorized Versions must be used for reproduction, and the Organizer agrees to remain current with version updates from the Train & Multiply website.
6. **No changes in content of any kind may be made** without the Train & Multiply Joint Venture's prior written consent. The Train & Multiply Joint Venture will sympathetically consider requests and will be flexible for any changes that will make T&M® more suitable for a local, social, ethnic and cultural situation.
7. **Project WorldReach and One Mission Society own the names T&M®, Train & Multiply** and any derivatives. Those names and symbols are legal trademarks. All Train & Multiply® materials shall bear the identification required and supplied by the Train & Multiply Joint Venture, as well as copyright information. All rights and translations shall always belong to the Train & Multiply Joint Venture.

8. **An annual report must be submitted to the Train & Multiply Joint Venture**, containing information including, a description of the effectiveness of the program, any problems, testimonies, etc., and the number of churches planted, leaders developed and T&M's impact on evangelism.
9. **Organizers and Users may not translate Train & Multiply® materials nor produce translations** without written consent by the Train & Multiply Joint Venture and completing a separate T&M® Translator's Agreement. Translation may only be done under guidelines and processes defined by the Train and Multiply Joint Venture.
10. **Organizer Training Requirements & License Fees:** Organizers who sign this License Agreement and pay an Authorized T&M Trainer USD 1.00 or its equivalent in local currency will be granted use of Level 1 T&M materials upon satisfactory completion of a Level 1 T&M training course provided by an Authorized T&M Trainer. Upon satisfactory completion of Level 2 T&M training course provided by an Authorized T&M Trainer, Organizers will be granted use of Level 2 T&M materials for USD 1.00 or its equivalent in local currency, payable to the Authorized T&M Trainer.

The Organizer receives a lifetime user License which allows the Organizer to print and use the Train & Multiply® materials as described in Appendix A of the License Agreement. This Organizer License Agreement is for one language and the digital user files associated with it. Licensed users, who have been trained by Authorized T&M Trainers, may purchase the digital files for additional languages from their Authorized T&M Trainer for USD 1.00 per language, provided they have completed the required T&M® training course.

Organizers who are not able to receive a T&M® training course from an Authorized T&M Trainer may sign this License Agreement and purchase T&M® materials from the T&M Joint Venture for \$750.00 US per language. They may pay by credit card via PayPal with a link on the Train & Multiply website.

Appendix A



Organizer Boundaries Defined

Train & Multiply® is a set of training materials distributable through an unbroken chain of Direct, Active, and Personal Accountability.

Please understand that the various Train & Multiply® agreements are part of a global strategy, which is intended to achieve improved and effective results in church planting and multiplication for Kingdom growth. The definitions of the “Organizer” help fulfill this strategy for effective ministry.

Organizers who have received training and coaching on how to use Train & Multiply® should name responsible coordinators who will keep churches reproducing after the initial T&M® trainees have started churches. With these responsible coordinators you will see more positive results. To keep the multiplication of churches going, Organizers must ensure timely training and coaching of pastoral workers. Those who misuse the materials by using them as reading materials without supplying training and coaching will not see positive results for church multiplication. Organizers who provide accountability through coaching on the use of T&M® will keep the chain unbroken.

Accountability, in this sense, does not refer to the lines of command within an organization itself, nor to a distant supervisor, base leader or regional director. The Organizer who does little more than provide materials to all teams, or groups over a large geographic area will not reach church multiplication goals. T&M® Organizer License Agreements are issued to individuals. Our intention is not to issue them to organizations, denominations or groups, but to individuals who may be part of any of these and who act according to our limits as defined.

Organizers must foster active and direct accountability in ministry for all those they mentor at the field level. In this way, even the most remote leader/pastoral worker in the training chain for multiplication have someone who listens sympathetically, who answers questions and provides guidance for all T&M® training and concerns. The Organizer ensures that trainers they have trained also remain actively, integrally, and vitally involved with the church planting effort, especially with those who are doing it “on the field”. Organizers must maintain strong relationships and active, working communications with pastoral workers.

The answer to whether someone can receive a full set or partial set of Train & Multiply® materials to use is governed by the Organizer License Agreement. Under this License Agreement only an Authorized T&M Trainer, an Organizer, or someone who is in a direct chain of mentoring with an Organizer can provide materials to someone else for use in the active ministry where direct accountability is maintained. In other words an Organizer, who is under contract, can have Train & Multiply® materials freely distributed, in unlimited quantities, to those who are accountable in ministry to the Organizer. This can extend very far, but there must be a direct, active, and personal accountability. If there is no such accountability, then anyone who wants to obtain, use, or distribute Train & Multiply® materials must enter into their own Organizer License Agreement.
